Focus on: Injuries

A key part of staff’s safeguarding responsibility in school is looking out for any unusual or unexplained injuries children may present. This is a legal duty of care that all members of staff have as part of their role within school. Whilst we understand that children will often have bumps and scrapes from day-to-day play, more significant or unusual injuries may warrant further questions to be asked. We will always ensure parents/carers are part of these conversations as appropriate, with the sole goal of ensuring children are kept safe at all times.



Focus on: County Lines



County Lines is a method of drug dealing by organised criminal groups (OCGs). These groups typically involve the movement of drugs from large cities in England to market and coastal towns and villages around the UK. They aim to establish new operations in these places.

County Lines is also a form of criminal exploitation that typically relies on older gang members grooming children from inner city areas. However, research highlights that gangs target younger children and this is happens frequently in Lincolnshire.

The gangs spot vulnerabilities and target these children to transport the drugs and money and manage the operation at the dispersed locations. It’s at these locations that further exploitation of local children follows. Often children can be groomed by offering material rewards and then use this to further exploit them.

WhatsApp

WhatsApp is a social messaging app from Meta that is used by over 2.7 billion people every month. Users can send text, voice and video messages, make voice and video calls and share information and documents. This app has become very popular with our students, especially in Years 5 and 6. Previously, users needed to be 16 years or older to use the app; however, in 2024 the age limit lowered to 13 years old.



This reduced age requirement allows more young people to use the platform. Additionally, children under this age still use WhatsApp to connect and communicate with friends, family and communities. While this can benefit children's wellbeing, parents must take action to make sure their accounts are safe at any age. Risks include inappropriate content or contact from strangers.
